5.1 Board’s Budget Update

2015/2016 BRN Budget and Reserve

Governor’s budget for FY 2015/2016 is \$43.4 million with 158.8 net personnel years (PYs). The Board’s fund condition shows a reserve for current year 2014/2015 of 1.0 month. The remainder of the fee increases went into effect on January 1, 2016. Projected revenue from the fees increase is \$2.447 million.

Current Year AG Budget

Pursuant to the Budget Bill Language in item 110-402, and based on the FY 2015/2016 expenditure projections (58% spent thru Dec. 2015), the Board is requesting an additional augmentation of \$959,833. Assuming that enforcement costs do not exceed current projections, this augmentation request would also allow for a minimal 1 month reserve.

The Board’s current year budget is going to be very tight and is being monitored to maintain the business of the Board and ensuring only necessary expenditures are being made.

5.2 Statutory Fee Bill

Louise Bailey reached out to the Senate Business, Professions & Economic Development and Assembly Business and Professions Committees to discuss initiation of a legislative fee bill for the Board of Registered Nursing.

5.3 Statement of Economic Interest, Form 700 Update

On January 27th the DCA e-mailed out the information on the electronic filing of the Form 700 to all those required to file. This will allow all board members and staff required to file online with an electronic signature. Deadline for e-filing is April 1, 2016, but the DCA has requested that everyone complete the e-filing by Friday, March 18th to ensure compliance.

Government Code section 91013 states that any person who files a Form 700 after the deadline (April 1, 2016) becomes liable in the amount of \$10 per day, up to a maximum of \$100. So please take some time to e-file your Form 700.

5.4 BRN Report Newsletter

The 2015 winter edition of the BRN Report Newsletter is now available on the BRN website. It includes BRN updates, information about recent legislative changes, overviews of BRN activities, updates on NCLEX and much more. The 2015 BRN Report can be found under the Forms/Publications tab or there is a link under the “What’s New” section, both on the homepage.

5.5 2014 – 2015 California New Graduate Hiring Survey

To better understand the employment experience of newly licensed RNs, a sixth annual statewide survey was conducted in fall 2015 through the efforts of HealthImpact (formerly the California Institute for Nursing and Health Care), the California Board of Registered Nursing (BRN), the Association of California Nurse Leaders (ACNL), and the California Student Nurses Association (CSNA) with funding provided by Kaiser Permanente Northern California Patient Care Services and Kaiser Permanente Nurse Scholar Academy.

Data from the survey reports a random sample of 5,283 (50%) out of 11,566 nurses newly licensed by exam in California between September 2014 and August 2015, were invited to participate in the survey. A total of 670 nurses completed the survey for a 12% survey response rate overall. The majority of newly licensed RNs responding to the survey indicated being employed as an RN with 74.2% reported to be working in their first registered nursing job, and 25.8% not yet working as a registered nurse. This data indicates a 9.1% improvement in employment from the prior year study and an overall trend for the third consecutive year.

5.6 Nursing Workforce Advisory Committee

The Nursing Workforce Advisory Committee (NWAC) met on November 17, 2015 at the BRN headquarters in Sacramento. The main focus of the meeting was to review and provide recommendations for the 2016 biennial RN survey instrument. Committee members also shared recent information and data collection related to the nursing workforce in California and discussed findings that impact working RNs and RN students. This committee was originally appointed by the Board in November 2001. The purpose of the Committee is to advise the Board members and staff of the BRN on current and projected issues affecting the nursing workforce including supply and demand, and issues affecting the ability of nurses to provide safe, accessible patient care and also to share information and data between agencies.

5.7 School Data on Website

At its September 3, 2015, Board meeting, the Board approved a format for presenting additional school and nursing program data on the BRN website per a recommendation from the Senate Committee on Business, Professions and Economic Development (BP&ED) and the Assembly Committee on Business and Professions (B&P) in response to the 2014 Sunset Review Report. The data includes institutional accreditation and individual program information regarding accreditation, attrition, and retention to better inform current and potential students as well as the general public.

All of the data, except for institutional accreditation, has historically been collected on the BRN Annual School Survey and this question was added to the 2014-2015 survey. BRN staff is currently working with University of California, San Francisco to review all of the data for accuracy, correct any errors and preparing for posting on the BRN website in the near future.

5.8 Breeze Release 2 Go Live

Release 2 of the BreEZe system was completed on January 19, 2016, and included eight DCA Boards and Bureaus. Currently there are a total of 18 Boards and Bureaus utilizing the BreEZe system. Implementation was relatively smooth and for the first week after go live BRN staff monitored work into and out of the system to ensure that functionality for the board was not affected by the implementation of the Release 2 boards. Staff continues to monitor BreEZe

activity and changes on a daily basis that could potentially affect applicants and licensees and brings any concerns to management's attention.

5.8 Public Record Requests

The BRN continues to comply with public record requests and responds within the required timeframes that are set in Government Code Section 6250. For the period of October 27, 2015 through January 27, 2016 the BRN received and processed 27 public record requests.

5.10 Licensing Program Update

The Licensing Program evaluators are currently processing the initial review of exam and endorsement applications cashiered in mid-November. The Board has received/processed 2,918 rosters from 81 California schools just for the month of December. During the month of December and January the focused was on processing the rosters and it has now shifted to evaluating the transcripts for those 81 California schools.

The Board is actively recruiting for eight positions in the Licensing Unit; two fulltime Staff Services Analyst (International Evaluator), two limited term Program Technician II (US Evaluator) and four limited term Program Technician (Support staff). These positions will be

dedicated to ensure that processing timeframes are being maintained within our statutory timeframes. I expect to have these positions filled by the end of March.

We continue to improve processes within the Licensing Program and project the Endorsement applications to be our next application to be released online. Once an applicant has created a BreEZe profile they can apply and pay for the Endorsement application which is in the development/testing phase and expected to be released this year.

Board staff continues to participate in the BreEZe Reporting User Group in order to create and implement a comprehensive statistical report. However the Department has been working on a new reporting system named Quality Business Interactive Reporting Tool (QBIRT) which is a web based reporting tool that will provide on-demand data reports/queries. The Board expects QBIRT to be released by the middle of this year.

5.11 NCLEX Pass Rate Update

The Board of Registered Nursing receives quarterly reports from the National Council of State Boards of Nursing (NCSBN) about the NCLEX-RN test results by quarter and with an annual perspective. The following tables show this information for the last 12 months and by each quarter.

The 2016 NCLEX-RN Test Plan is effective April 1, 2016 through March 31, 2019. The NCLEX-RN Passing Standard will remain at the current level of 0.00 logit that was instituted April 1, 2013. This passing standard will remain effective through 3.31. 2019. A logit is a unit of measurement to report relative differences between candidate ability estimates and exam item difficulties.*

Nursing Programs were notified of the above info via e-blast and this information will be included in the upcoming BRN Newsletter.

Nursing Education Consultants (NECs) monitor the NCLEX results of their assigned programs. If a program's first time pass rate is below 75% pass rate for an academic year (July 1-June 30), the NEC sends the program written notification of non-compliance (CCR 1431) and requests the program submit a written assessment and corrective action plan to improve results. The NEC will summarize the program's report for NCLEX improvement for the ELC/Board meetings per the Licensing Examination Passing Standard EDP-I-29 document approved 11/6/13. If a second consecutive year of substandard performance occurs, a continuing approval visit will be scheduled within six months, and the NEC's continuing approval visit findings reported to ELC with program representatives in attendance.

The Education/Licensing Committee met on January 14, 2016 and makes the following recommendations:

APPROVE MAJOR CURRICULUM REVISION

Dr. Christy Torkildson, Program Director.

Unitek College, founded in 1992, is a proprietary school based in Fremont, California. Initial approval for the LVN to RN program was granted February 16, 2007 and the first cohort was admitted in March 2007. The program submitted a major curriculum revision proposal to continue the LVN-RN program and to add a generic Associate Degree Registered Nursing Program. The change is planned to take place May 2016. The generic ADN program will be four (4) semesters with each semester being seventeen (17) weeks. The program requests the addition of two cohorts of 40 students each for the generic program and the continuation of the advanced placement LVN to RN enrollments of 120 students per year, with three starts per year. The total number of students planned will be 200. Benner's theoretical framework simple to complex and the integration of theory with clinical concept-based competencies, BRN standards of competent performance, QSEN, nursing process and physical, behavioral, and social aspects of human development and

Jean Watson's Theory of Caring will be threaded through the program. The philosophy, goals, and objectives focus and intent will not change.

The program received letters of support from the respective clinical facilities. The program has submitted facility approval forms for the additional clinical needs for the generic program. The generic program will utilize extended care and sub-acute clinical settings for first and second semester to meet the program objectives. The generic program third and fourth semesters will utilize facilities that are used currently for the LVN-RN program. The program plans to teach out the current LVN to RN cohorts using the current curriculum and start new cohorts with the new curriculum. Advanced Placement students pay \$42,000 inclusive of all fees, books, supplies, uniforms and licensing fees. The planned tuition for the generic associate degree nursing program is ~\$68,000, all inclusive. The program is scheduled for a regular continuing approval visit Fall 2016.

7.5 Vote on Whether to Accept Staff Plan for Implementation of SB466 Requirements Regarding Education Regulations

Miyo Minato, NEC and Leslie Moody, NEC presented this report.

BACKGROUND: SB466 approved by the Governor and filed with the Secretary of State on October 4th (see attachment for full text) contains amendments to the Business and Professions Code requiring action for regulation and processes affecting prelicensure nursing education. Section 2786.1 is added to the Business and Professions Code, to read in part:

(a) The board shall deny the application for approval made by, and shall revoke the approval given to, any school of nursing that does not give student applicants credit in the field of nursing for military education and experience by the use of challenge examinations or other methods of evaluation.

(b) The board shall adopt regulations by January 1, 2017, requiring schools to have a process to evaluate and grant credit for military education and experience. ...

(c) The board shall review a school's policies and practices regarding granting credit for military education and experience at least once every five years to ensure consistency in evaluation and application across schools. The board shall post on its Internet Web site information related to the acceptance of military coursework and experience at each approved school.

Attached are draft proposed regulatory language and a proposed timeline of required activities that will ensure compliance with requirements of SB466 in regards to nursing education.

ELC Recommendation: Authorize BRN staff to perform the following

- regarding (a) and (b): Staff will initiate the rulemaking process for regulation to operationalize the new statutory requirements which will include circulator of draft language to stakeholders for review/input, convene public hearing, and other required activities. Staff may make nonsubstantive revisions to draft regulatory language in response to stakeholder input.
- regarding (c): Inform Nursing Education Consultants of requirement for review of policies/practices related to school granting credit for military education and experience as part of scheduled program approval activities.

Require BRN-approved nursing programs to post information related to the acceptance of military Course work and experience at their school on their webpage reached via the link provided on the BRN website approved programs list. Deadline for nursing programs to meet this requirement will be January 1, 2017.

Information regarding the above was informally disseminated to interested parties and stakeholders including statewide program deans/directors to obtain preliminary input for consideration of the Board.

7.6 2014-2015 Annual School Survey Reports (Draft)

Background: The BRN 2014-2015 Annual School Survey was conducted from October 1, 2015 to November 16, 2015. The survey was sent to all California pre-licensure nursing programs and was conducted on behalf of the BRN by the Center for the Health Professions at the University of California, San Francisco. The BRN would like to thank all of the schools for their participation and prompt responses to the survey and the Education Issues Workgroup for contributing their time and assistance on the survey document and reviewing reports.

BRN and UCSF staff work each year with nursing program directors who make up the Workgroup, representing various prelicensure programs from around the state who review and edit the survey questions if needed. This allows the survey to be a current document that can be used to capture data on new and emerging trends.

The draft of the statewide Annual School Reports includes data on new and continuing student enrollments, graduations, faculty, etc. from California pre-licensure nursing programs. There are two reports; one is a trend report which includes historical data for the past ten years on some of the more significant data and the second includes current year detailed data from most all of the questions asked on the survey.

9.1 Complaint Intake and Investigations Update

Shannon Silberling, Deputy Chief, Complaint Intake and Investigations presented this report.

PROGRAM UPDATES

COMPLAINT INTAKE:

Staff

We have filled our 12 month limited term Associate Governmental Program Analyst position. It was filled with a Complaint Intake Staff Services Analyst (SSA). The SSA is now being recruited for as a limited term position.

Program

Complaint intake continues to work new complaints, ensuring cases are moving to investigations in a timely manner and that aging cases are worked as a priority.

We have one analyst that is working with the Department of Consumer Affairs (Department) BreEZe team and is involved in the Reports User Group, as well as the Enforcement User Group.

The Controlled Substance Utilization Review & Evaluation System (CURES) had a soft launch July 1, 2015. CURES 2.0 is being rolled out over the next couple months. The BRN continues to work closely with the Department’s Executive team and the Department of Justice (DOJ) to ensure its success.

INVESTIGATIONS:

Staff

We are currently fully staffed in both Northern and Southern California.

Program

Division of Investigation (DOI) has begun the quarterly Managers' Enforcement Consortium and we had our second meeting on September 28, 2015, with guest speakers from the AG's office.

We continue to assign cases based on the Department's Consumer Protection Enforcement Initiative (CPEI). As of October 27, 2015, there were approximately 37 BRN cases over one year old that are still open and there are approximately 21 DOI cases over one year old that are still open.

Investigative staff continues to attend Task Force meetings and develop working relationships with allied agencies.

9.3 Intervention Program Update and Statistics

Don Walker, Program Manager presented this report.

Staffing

The Intervention unit filled the vacant Office Technician position with an internal transfer from the licensing unit.

Program Update

Effective January 1, 2016, Pursuant to Senate Bill 800, the official name of the Diversion Program changed to the Intervention Program. In preparation of the name change, Intervention staff worked diligently to update the program's policies, correspondence documents and website to reflect the program's new name.

CPS HR Consulting has conducted a contract and performance audit of MAXIMUS, the Intervention program's contractor. A draft audit report has been submitted to DCA for review of the audits findings and recommendations.

On November 4, 2015, Intervention staff and Virginia Matthews, MAXIMUS Project Manager provided an educational Intervention Program presentation for the Los Angeles County University of Southern California Medical Center Nursing Leadership's Management Team. The presentation was well attended and the attendees indicated they appreciated the opportunity to learn about the Diversion Program and its role in public protection.

On November 19, 2015, Intervention staff and Virginia Matthews, MAXIMUS Project Manager conducted a presentation for the Association of Kern County Nurse Leaders (AKCNL). An important takeaway to this presentation was that irrespective of ones position in the nursing community whether its management or rank and file, no one is immune to substance use disorders and/or mental illness.

On December 2, 2015, MAXIMUS staff conducted a presentation at California State University of Sacramento (CSUS) to 77 Public Health Nursing students regarding substance use disorders, mental illness and how the Intervention program provides assistance for nurses in need.

On February 3, 2016, Intervention staff and Virginia Matthews, Maximus Project Manager conducted an outreach presentation to the Nursing Leadership Group at Sharp Memorial Hospital in San Diego. The presentation focused on the nature, progression, and prevalence of Substance Use Disorders and how to identify signs of medication diversion in the healthcare setting.

Intervention Evaluation Committees (IEC)

There are currently two physician member vacancies at this time. One vacancy is in Burbank (IEC 8), and the second vacancy is in North Central (IEC 12).

There are currently four RN member vacancies at this time, one in Sacramento (IEC 1)*, one in Orange County (IEC 4), one in Burbank (IEC 8) and one in Santa Ana (IEC 14)*.

There are currently two Public Member vacancies at this time. One vacancy is in Los Angeles (IEC 3)*, and the second is in Ontario (IEC 9)*

The Emergency Medical Services Authority announces that the *lay rescuer epinephrine auto-injector training certification standards* regulations were approved by the Office of Administrative Law on October 16, 2015 and became effective January 1, 2016.

On January 1, 2016 the EMS Authority can begin reviewing and approving training programs to provide training and certification for the administration of epinephrine auto-injectors to lay rescuers and off-duty EMS personnel.

Certification from an approved training program will allow a layperson or off-duty EMS personnel to obtain a prescription for and administer an epinephrine auto-injector for use on a person experiencing anaphylaxis, with civil liability protection, when acting in good faith and not for compensation.

10.4 Information Only: RN Role Reimagined –How Empowering Registered Nurses Can Improve Primary Care by California Healthcare Foundation August 2015

Strategies for Changing the RN Role (Please read the attachment for CHCF report)

1. Provide RNs with additional training in primary care skills, so they can make more clinical decisions
2. Empower RNs to make more clinical decisions, using standardized procedures

3. Reduce the triage burden of RNs to free up time for other responsibilities
4. Include RNs on care teams, allowing them to focus on their team's patients
5. Implement RN-led new patient visits to increase patient access to care
6. Offer patients co-visits in which RN conduct most of the visit, with provider joining in at the end
7. Deploy RNs as "tactical nurses"
8. Provide patient with RN-led chronic care management visits
9. Employ RNs' skills to care manage patient with complex health care needs
10. Train some RNs to take responsibility for specialized functions
11. Schedule RNs to perform different roles on different days
12. Preserve the traditional RN role and focus on training MAs and LVNs to take on new responsibilities.

This report explores how safety-net clinics are responding to the challenge of using RNs' skills. The report focuses on community health centers and county health systems in California; two health centers outside California are listed.

The report identifies the American Academy of Ambulatory Care Nursing (AACN) recognizing the "evolving medical home concept reinforces the critical need for registered nurses to provide chronic disease management, care coordination, health risk appraisal, health promotion and disease prevention services"
