This regulatory action by the Board of Registered Nursing (BRN) within the Department of Consumer Affairs (DCA) amends section 1419(c) of title 16 of the California Code of Regulations, which relates to the requirements for renewal of a nursing license. As a condition of renewal, an applicant must disclose whether he or she has been convicted of any violation of law since the last renewal of his or her license, omitting traffic infractions under \$300 not involving alcohol, dangerous drugs, or a controlled substance. This action amends the minimum reporting level for traffic infractions to \$1,000.

OAL approves this regulatory action pursuant to section 11349.3 of the Government Code. This regulatory action becomes effective on 4/22/2014.

## ORDER OF ADOPTION

The Board of Registered Nursing hereby amends the following regulation in Division 14 of Title 16 of the California Code of Regulations.

- (1) Amend subsection (c) of section 1419 of Division 14 of Title 16 of the California Code of Regulations to read as follows:
  - 1419. Renewal of License.
- (c) As a condition of renewal, an applicant for renewal shall disclose on the renewal form whether, since he or she last renewed his or her license, he or she has been convicted of any violation of the law in this or any other state, the United States or its territories, military court, or other country, omitting traffic infractions under \$300 \frac{\$1,000}{} \text{ not involving alcohol, dangerous drugs, or a controlled substance.
