5.1 Executive Officer report

Board Discussion:

Patricia Wynne appreciated the information and the team. She asked when everything will be completed. Executive Officer Melby said all goals should be completed by the last Board meeting in 2025. Patricia Wynne asked if there was an egregious case in enforcement that could be streamlined and done faster. Executive Officer Melby explained the PC 23 process saying staff can show up at the criminal proceeding and have a license immediately revoked. She then explained the Interim Suspension Order (ISO) process. Public protection is immediately addressed through the PC 23 and ISO process.

Mary Fagan echoed Patricia Wynne. She asked if a completion percentage can be added to the information. Executive Officer Melby said she is unsure if this can be done because, many times, when one item is completed another issue comes up and it is difficult to quantify it. They discussed how many processes are Pandora's

Boxes. Mary Fagan asked about the customer satisfaction survey process. Executive Officer Melby said the information is reported out during the Sunset process. Because the Board was extended for four years, Executive Officer Melby said she would look to report the information out with the most recently reported data. Mary Fagan asked if the customer service information could be reported at the next meeting. Executive Officer Melby said she would report out the data but, because of the data collection and analysis, she is unsure what meeting date it would be presented at.

Patricia Wynne asked about money going to the General Fund and the loan repayment. Suzanne Balkis said they are tied together.

Executive Officer Melby said the Board has a healthy fund and is looking at process improvements and possibly lowering fees. She said that the BRN's fund has been artificially inflated due to Covid because of the influx of RNs into California. She said the Licensure by Exam fees paid by California graduates may be reduced because the process is almost 100% automated.

5.4 **Information Only:** Presentation by University of California, San Francisco on analysis of nursing workforce conducted pursuant to

Business and Professions Code section 2717

Presented by Joanne Spetz, University of California, San Francisco

Board Discussion:

David Lollar asked about the large university who did not report their data. He asked if they would report their missing data. Joanne Spetz said the school reported 2022 data but does not know if or when they will report missing data. Executive Officer Melby said she is working with the program who is interested in coming into full compliance with the Board and hopes to see them at the November Board meeting. She explained NCLEX test data that is reported to the Board from the exam vendor.

Dolores Trujillo asked about the 7.2% vacancy rate and where it comes from. Joanne Spetz said the Hospital Association of Southern California does a quarterly turnover and vacancy report for many years. She also said CNOs are surveyed, and they are trying to merge the data together. Dolores Trujillo asked about the 5-year projection. Joanne Spetz said the schools say how much they expect to grow to help project graduations out four years. She tries to be conservative in the projections.

Executive Officer Melby asked about workforce planning as it has been difficult to pull data for the Board. Asked if there was data of the number of students who need to be in the nursing pipeline to ensure the Board meets the 2027 balance and further explained data needs to assist the Board making enrollment decisions. Joanne Spetz said she got a call from a legislative staffer asking about how to solve the workforce shortage. She said the data shows that the schools should be graduating over 16,000 nurses in the 2025 school year which is 4,000 more than now. She explained other agencies she's working with to help achieve the goals of California. Executive Officer Melby spoke about sharing the number of nursing students and percent of registered nurse licensees with NCSBN.

David Lollar asked about the FTE regional slide showing the differences throughout the state. Joanne Spetz spoke about the changes in the state throughout the years as it relates to rural communities, availability of nursing education, population changes, etc. Executive Officer Melby added information about enrollment increases in the San Bernardino area.

Vicki Granowitz said she's been reading about education deficiencies because of COVID and how that might be an issue down the road. Joanne said that could be a piece of the small increase in the percent of students who are delayed in their progress. She is concerned how this will affect communities of color and lower income families as to how that could impact the movement towards diversifying the nursing workforce. She spoke about work to foster first generation nursing students.

Mary Fagan appreciated the information in assisting the Board make enrollment decisions. She asked about the difficulty predicting demand. Joanne Spetz spoke about nursing enrollment projections and EDD data which is largely built off the US Bureau of Labor Statistics projections which isn't incredibly accurate at a single occupation level. Mary Fagan asked when the final report should be released. Joanne Spetz thought the report should be released in August. Executive Officer Melby said there are several validation

steps before it is published which should be at the beginning of next year. Joanne Spetz said she'll look at where the regionals are at and if it might be ready to share with the Board at an upcoming meeting. Executive Officer Melby explained what information can and cannot be considered by the Board about enrollment increases. Joanne Spetz said there is data in the confidential spreadsheet that is available for the NECs to look at.

Marie Gilbert, Director for Center of Excellence in Nursing: Said she was surprised by the green showing in Fresno for nurse to population ratio. She said Fresno is desperate for nurses and is not sure that is reflected in the data. Joanne Spetz said nurses per capita does not reflect projected growth of population in the community. Fresno county is one of the faster growing counties in this state and does not account for distribution of older nurses or educational capacity.

6.1 Information only: Operation Nightingale

Board Discussion:

Dolores Trujillo asked if the original numbers reported for California included APRNs. Executive Officer Melby said no APRNs were included in the numbers and further explained that APRNs are unable to endorse into California. An applicant must apply for both the RN and APRN in California. Dolores Trujillo asked about the 110 applicants who were denied and if they all were from Florida. Executive Officer Melby said they were all from Florida.

Shannon Johnson, Enforcement Chief, explained the application denial process.

Elizabeth Woods asked if some students had no nursing education at all and were given diplomas. Executive Officer Melby said that is true.

Patricia Wynne asked if applicants who attended these specific schools were automatically denied or was there any additional investigation done. Executive Officer Melby explained that lists were provided by the FBI showing some schools graduated legitimate students, some students were issued fake diplomas. If applicants are not on the FBI list, then additional investigation is done. Shannon Johnson said there are now 127 applicants who have been denied. She said when she cross-checked the lists there was one who legitimately graduated from one of the programs.

Public Comment for Elissa Brown: Stated that she was appalled by this report and asked **Agenda Item 6.1:** if this has been going on for six or seven years. She thanked the Board for doing this and alerting the public. Executive Officer Melby said every student was aware they were participating in this.

> ADW – Executive Officer Melby read the written comment – How many were found in California? There are over 500,000 licensees in the state. Executive Officer Melby gave additional information about the investigation process.

Gene Wilkes: Stated he attended a Florida nursing program and thinks this is appalling. He didn't think all students should be grouped into one category. He thought there are more factors that should go into a full investigation and he questioned whether the investigations have been done in an expeditious manner. He is an applicant from one of these programs but says he was told he is deficient; however, the Board has the information needed to make a decision. Executive Officer Melby said this is an ongoing investigation where more schools are being investigated by the FBI. She said this is more prevalent in the associate degree nursing programs and BRN is looking at each of the programs carefully; therefore, some students are in a holding pattern as a result. If the FBI says a school is fraudulent then any applicants will be denied. She said a bachelors program noticed NCLEX failures and found that people are claiming graduation from legitimate programs but did not attend.

Board Discussion:

Jovita Dominguez said she believed the program has approval for the clinical sites and it is being done during nights and weekends in the summer. Dolores Trujillo asked about Fall continuous enrollment. Executive Officer Melby said the program is already approved for 40 students in Fall and Spring.

Patricia Wynne stated that she would like to hear from the Program Director and how it might affect others.

David Lollar asked if Loretta, or the Program Director, could explain how 40 students would have an impact on an area that large.

Rebekah Child, Program Director, said they are the only CSU in the San Fernando Valley serving Hispanic students and nursing education to their community in the San Fernando Valley. She said hospitals are coming to them for their graduates. She said they've always looked to not displace any other students and explained that 40 students are a drop in the bucket. She also said their program is fair with tuition.

Mary Fagan asked about the two programs that said they would be impacted by the additional students. Rebekah Child said one was Pierce Community College and the other one is College of the Canyons. She said the majority of hospitals used by the other schools are not used by CSU Northridge. She said there is an issue with psychiatric rotations and Northridge will seek other sites that would not impact College of the Canyons. She spoke about the community college students seeking a BSN at CSU Northridge that should not kick out any clinical placements. Executive Officer Melby shared her computer screen to show the various nursing programs near CSU Northridge and discussed enrollments that could be affected by this. She said it was good that CSU Northridge is working with the surrounding programs.

Jovita Dominguez appreciated CSU Northridge reaching out to the other programs.

Vicki Granowitz said she was unsure how to take the information since most programs talk about how they don't displace others while there continues to be displacement. Executive Officer Melby presented her screen again to show the various schools and how close they are to each other. Vicki Granowitz said she grew up in this area and it is close to LA. Rebecca Child said no one in Northridge wants to go over the hill to LA because of the terrible traffic.

Dolores Trujillo suggested hearing public comment before making a motion.

Rebekah Child said she will include the agreements made with the other programs in her faculty meeting minutes. Mary Fagan asked about Pierce College. Rebekah Child said they don't use the same hospitals.

5. AB 1063 (Gabriel) Nurse-to-patient staffing ratios: annual report

Board Discussion: Mary Fagan was concerned it doesn't say that the California Department of Public Health (CDPH) isn't going to create new reporting requirements for hospitals then about staffing ratios and what the impact would be. She said there's already so much reporting done, it keeps people from being able to care for patients.

> Dolores Trujillo asked if reporting being done by CDPH for exceptions. Marissa Clark said CDPH would like a review of enforcement of the regulations and then submit an annual report to the legislature that would touch on three main things: number of reports received by CDPH alleging a violation of ratio regulations, the investigative steps taken by CDPH in response to those reports and outcome of any investigations, and complete listing of allegations found to be unsubstantiated in the basis for the findings. They would also have to do a public hearing soliciting input from direct patient care nurses and include recommendations and whether or how they're implemented. If they are not implementing the recommendations, then why they are not.

Dolores Trujillo wanted to know if ratios are being enforced. She didn't recall reading a report this is being enforced.

Elizabeth Woods asked how this information is gathered. Dolores Trujillo said it could be their website. Marissa Clark said she thought language is already in place for reporting.

Patricia Wynne asked is there is a feeling out there from staff nurses that ratios are not followed. Executive Officer Melby discussed issues with nursing ratios both current and historical. The BRN does not have any jurisdiction regarding staffing ratios since it is in Title 22; however, the patient safety component can impact BRN in enforcement.

Mary Fagan was concerned about reporting the unsubstantiated claims and the work that would go into this process at the hospitals. She said it might be helpful to know what is already required. Marissa Clark said she can get that information.

The Board members thought a watch position would be good at this point.

Jovita Dominguez said nurses should feel empowered to speak up if a facility is going to be out of ratio.

Elizabeth Bamgbose, CANA: Reiterated what Melanie Rowe said about AB 765, supports fixing this within BRN regulations.

Elissa Brown, CNS: Agreed with most BRN positions and most nurses are against AB 765. She spoke about ratios.

Dr. Ileana Meza, DNP: Asked the Board to oppose AB 765. Whenever she sees patients, she introduces herself as a nurse practitioner. She acknowledges that it helps to educate the public.

Board Discussion: Executive Officer Melby said there is quite a high interest in this bill

so public comment could be opened for this bill.

Patricia Wynne said she's had great anxiety about this bill and

would like to hear the public comment.

Mary Fagan agreed with Patricia Wynne. Vicki Granowitz also

agreed with Patricia Wynne.

Reza Pejuhesh asked if there would be separate public comment for each bill. Dolores Trujillo said there would be public comment for this bill and additional public comment for all other bills at the end of

the presentation.

After public comment:

Dolores Trujillo said the Board could change the position based on

public comment.

Patricia Wynne said she's persuaded by both public comments heard today in opposition to the bill and the opposition letters submitted. Her fears are more aligned with the concerns of the opposition than the proponents of this bill. She was in favor of changing the Board's position from support to oppose.

Vicki Granowitz continued to oppose this bill. She thought we as a culture often flip flop from one extreme to another and that if this bill is passed then in another decade, we'll be amending it. She thought a better idea is to amend it with some of the suggestions in the opposition letters. She said children who were sexually assaulted would easily not be reported under this bill.

David Lollar said he thought this bill has been with the Board for a long time and he originally opposed it vigorously and aggressively. He respectfully listened to the voices supporting this bill but hearing public comment today reminds him of how torn he is because he opposes it. He was concerned about those who are supporting it. He was listening to Cal-Safe's ideas to change the language and what is happening in rural communities and is again leaning towards opposing this again and changing the Board's position.

Executive Officer Melby clarified that what Vicki Granowitz said about reporting child abuse, etc. is not affected by this bill. Child and elder abuse continue to be mandatory reporting. She said she and Marissa Clark continued to have conversations with the author and supporters and discussed the same items Cal-Safe has suggested for improvements.

Dolores Trujillo said she would like to see an "Opt In" or "Opt Out" added in. Executive Officer Melby described the sexual assault nurse examination process and maintenance of medical evidence in the process to allow the survivor to report. She discussed the addition of the warm handoff that was not part of the previous process.

Vicki Granowitz said Colorado included mandatory reporting for domestic assaults with serious bodily injury or Tennessee requires it for life threatening injuries including strangulation. Language could be taken from what's working in other states. She was ambivalent about the idea of giving survivors the choice because some are afraid of their perpetrator that unless there is mandatory reporting, they won't do it.

Dolores Trujillo said if the Board takes an Oppose Unless Amended then suggested language could be provided. Executive Officer Melby said they could do that. She explained how this could help the author's office. She said they've been working on the documentation aspect with the author's office. Some of the changes are in alignment with what Cal-Safe wants as well. Marissa Clark said Oppose Unless Amended sends a stronger message about the suggested changes. But there is a position the Board could take to

work on any changes to the bill. Executive Officer Melby said Oppose is a strong message. Unless amended lets it continue to move through the process.

David Lollar said Oppose Unless Amended aligns with Cal-Safe. He said the warm handoff is an important component.

Patricia Wynne aligned herself with David Lollar's comments. She said there are 58 counties in California, and we only heard from someone in two of the counties. The Board doesn't know what's happening in the other counties.

Jovita Dominguez said it's sad what happens to families that you're supposed to be safe with and men and women are very vulnerable with this kind of violence in their homes

Reza Pejuhesh said the Board could withdraw their original position if not convinced either way or want the Board to be on the record for it

Executive Officer Melby read in some of the written comments submitted in Board meeting materials. She said the Board's concerns have been raised with the author's office and suggested language changes have been provided.

Dolores Trujillo thought the motion should be to withdraw previous position and Oppose instead.

Mary Fagan was in favor of either Oppose or Oppose if Amended. Vicki Granowitz agreed with Mary Fagan.

Patricia Wynne wondered if the bill can be fixed with a few amendments. She was leaning towards Oppose. Dolores Trujillo was also.

Executive Officer Melby spoke about incident reporting. She asked Marissa Clark if this is a two-year bill if the issues cannot be worked out. Marissa Clark said a position of Oppose Unless Amended is a good choice versus Oppose to say the Board wants to see where the bill is going and be able to have input in the outcome.

David Lollar appreciated the clarification and agreed to give them another chance to figure out how to amend it.

Vicki Granowitz said legislators are willing to listen to comments if you're in the game rather than saying we're opting out. They're a

little more receptive because there's still an opportunity to see what they're trying to do.

Marissa Clark said the bill is still moving in this session but if the sponsor and author decided that rather than risk it, they could stop the bill at any point. It will go to Senate Public Safety Committee and there could be an action to hold it.

Patricia Wynne does not know what amendments could be made to make the Board support this bill. She agreed with Oppose Unless Amended to keep the Board in the conversation but maybe the Board doesn't need to be involved in this since we don't support the premise of the bill.

Executive Officer Melby said mandatory reporting does not need to be deleted to keep the warm handoff. There are a lot of different ways the language can be amended to accommodate the Board's wishes. She spoke about the barriers that survivors face in seeking care based on law enforcement involvement. There was a lot to take in and work with. There were many unintended consequences of this bill.

Vicki Granowitz spoke about a disconnect with the reported data that isn't clear. She doesn't trust what's in the literature because it is all over the place.

Dolores Trujillo said a motion can be made to withdraw support unless amended. She was hearing the Board wants to Oppose. The Board is in favor of reporting, but this bill does not do just that. She said Oppose or Watch. Vicki Granowitz and David Lollar both support Oppose.

Public Comment for Malinda Wheeler, RN, NP, President of CALSAFE: Sexual **AB 1028:** assault nurses oppose this bill as written. This bill reverses the work done to create the mandatory reporting. Domestic violence is on the rise and this bill causes many unintended consequences. They have been working with the author's office and sponsor to amend the language, but no agreement has been made. They agree the language needs to be amended. They proposed a more nuanced and measured approach, for example, in-person advocacy with an opt-out option to soften the language. They want to protect the most

seriously injured patients who present to the Emergency Department and urgent care settings. She asks the Board to support the forensic nursing experts to better guide the amendments to Penal Code 11160.

Jacqueline Winters Hall, RN, PHN: Stated that she is a sexual assault forensic nurse examiner in rural northern California. She respectfully and strongly opposes AB 1028 as currently written. In Butte and Glenn counties and many other rural counties, advocacy agencies, including rape crisis are not provided in person services since prior to March of 2020. She provides exams for pediatric, adult, adolescent, and geriatric patients every day. The Emergency Department, trauma, and sexual assault response team provides care to patients who are victims of violence. They make sure the patient has contact information for community resources for domestic violence and sexual assault but there's no guarantee the patient will connect with the desperately needed resources, especially since advocacy doesn't come to the hospital. Some communities have no advocacy at all.
