Dear Members of the California Board of Registered Nursing,

I am writing this letter on behalf of Riverside Community Hospital. We support West Coast University's ("WCU") application with the California Board of Registered Nursing to maintain its current student enrollment. Nearly 30% of the new nurses employed at Riverside Community Hospital are WCU grads. I have found that WCU students receive excellent academic preparation and clinical instruction, and upon graduation, these students easily transition into nurses who are ready to serve patients and have a passion for the nursing profession.

While the shortage of nurses is a concern for the entire state of California, it is also a regional concern for Riverside County. Riverside County is currently designated on the Registered Nurse Shortage Area (RNSA) by the California Healthcare Workforce Policy Commission and the U.S. Bureau of Labor Statistics estimates that Riverside County will see a 15.5% increase in the demand for nurses in the next year. Because of the severe shortage of registered nurses in Riverside County, it is imperative to our community's health and well-being to maintain or increase the number of nursing students graduating from well-regarded institutions like WCU. Decreasing WCU student enrollments would be detrimental to patient safety at our hospital and devastating to California's nursing workforce pipeline overall.

For these reasons, we urge the California Board of Registered Nursing to allow WCU to maintain its current student enrollment to allow for continued stability in California's nursing workforce pipeline.

Dear California Board of Registered Nursing:

Hollywood Presbyterian Medical Center (HPMC) is a clinical partner to West Coast University (WCU), and we support WCU's application with the California Board of Registered Nursing to maintain its current student enrollment capacity. HPMC relies on WCU as an essential provider of new graduate nurses, and WCU alumni have proven to be well-prepared for the nursing profession. To be sure, HPMC has hired over 70 WCU graduates over the past three years.

As you know, experienced nurses are retiring and leaving the workforce faster than nursing graduates can replace them. As a result, community hospitals like ours continue to face nursing workforce challenges, while many prospective nursing students are being turned away from nursing programs across the state because of capacity limitations. WCU is a primary source of Southern California's nursing workforce, and any decrease in student enrollment will worsen workforce challenges for all healthcare organizations, including HPMC.

Another important aspect to HPMC's nursing workforce is ensuring diversity and closing the gaps of inequity in healthcare. By 2030, communities of color will make up over 65% of California's population, yet they are severely underrepresented in the healthcare workforce and educational pipeline.¹ Nearly 80% of WCU's student body identifies as persons of color, which shows that WCU is a lifeline for student access. Many of the hospitals that WCU partners with for student clinical experiences and new graduate employment, including HPMC, are community-based hospitals that serve diverse populations, including lower socioeconomic communities. Decreasing WCU's student enrollment capacity has the potential to perpetuate underrepresentation in the healthcare workforce.

Overall, any reduction in WCU's student enrollment will have widespread negative effects on the statewide nursing shortage and will hinder efforts to promote diversity and inclusivity in the healthcare industry.

Children's Hospital of Orange County (CHOC) is one of thirteen children's hospitals in California and the only children's hospital system in Orange County, CA. CHOC supports West Coast University's application with the California Board of Registered Nursing to maintain its current student enrollment. As the second largest provider of BSN-educated nurses in California, WCU is an essential source of the nursing workforce across CHOC's network.

CHOC hires WCU graduates because they are well-equipped to care for our patients and their families. An added benefit of WCU's BSN program is that approximately 80% of WCU students identify as people of color. CHOC serves a diverse population across Southern California, and as part of our efforts to diversify the workforce, we recognize that WCU students and alumni have the ability to positively impact patient health through their cultural competencies and excellent academic preparation.

Given the competitive nature of recruiting nurses, decreasing enrollment for WCU students will limit CHOC's ability to staff its facilities and will immediately impact the current nursing shortage in California. Additionally, any decrease of WCU student enrollment may also have the unintended effect of limiting academic options for students of color.

We request that the Board allow WCU to maintain its current student enrollment to ensure that the supply of high-quality nurses does not further decrease as the nursing workforce shortage continues to worsen.



RE: Maintaining Existing Annual Enrollment for California Baccalaureate of Science in Nursing (BSN) Programs

Dear Board of Registered Nursing Members,

It has come to my attention the Education Licensure Committee will be reviewing annual enrollment for select Baccalaureate of Science in Nursing (BSN) programs during their October 2023 hearing. I am respectfully requesting the Licensure Committee and Board at-large maintain and approve, at minimum, the existing annual enrollment patterns for all programs seeking approval.

The State has continuously highlighted its efforts supporting our nursing programs as evidenced through the continuous engagement of both the Legislature and Administration. California's robust nursing education system is a model to the rest of the nation and continues to produce some of the most qualified nursing professionals worldwide. Unfortunately, the State continues to project a significant deficit in workforce supply amidst the continued stresses on the healthcare system. According to the Hospital Association of Southern California, nursing vacancy rates among local hospitals exceed 30%.¹ Prior to the pandemic, the average vacancy rate was 6%. As noted in the Board's own research report from August 2022, many older RNs have left nursing, and many continue to look to leave or retire in the coming years.² Similarly, the 2023 survey reveals since 2021, RN career satisfaction and the percentage of nurses who are likely to encourage others to enter the nursing field have dropped, while feelings of burnout have risen.³ This leaves California in a perilous situation of a declining workforce compounded by constituencies with increasing need.

It is imperative swift and reasonable actions are taken to ensure a sufficient pipeline of nursing students and graduates. At minimum, Universities must maintain their existing enrollment so access to care does not suffer. I strongly urge you to support any University's application to maintain its current enrollment patterns and further seek to increase placements at qualified institutions to meet the needs of our state.

Dear Board of Registered Nursing Members,

I write in support of West Coast University's (WCU) application to maintain its existing annual enrollment of 220 core nursing students each term (five terms per year) of its Baccalaureate of Science in Nursing (BSN) program for each of its California campuses, located in Anaheim, Ontario, and Los Angeles. This is anticipated to be on the agenda for consideration during the October 2023 Education Licensure Committee meeting and November 2023 Board of Registered Nursing full meeting.

WCU was established in 1909 and is well known for its preeminent academics and as California's largest provider of BSN educated nurses outside of the CSU system. WCU's strong record of accomplishment of excellence in BSN nurse preparation is evident with a current campus-wide 93.6% first-time NCLEX pass rate (BRN Quarter 4, 2023), employable graduates earning over \$100,000 annually, and an exceptionally low federal loan cohort default rate of 0.1%. In addition, 80% of the WCU student body identifies as diverse, therefore greatly contributing to our state's strives to address healthcare inequities. Many of the students live in multi-generational families, speak a second language and chose WCU rather than to hold their future while on a waitlist.

WCU graduates are filling critical nursing roles in our constituencies that support the funding and policy priorities set forth by Governor Newsom and the legislature. The 2023-2024 Budget Act invested \$988.4 million in total funding (\$188.8 million in 2022-23, \$314.7 million in 2023-24, \$427.3 million in 2024-25, and \$57.5 million in 2025- towards addressing shortages in care for the opioid crisis, access to behavioral health services and meeting the needs of our aging population. WCU students train in all of these areas and graduates are working in Community hospitals, Psychiatric hospitals, as public health nurses and many more positions that that align with Governor Newsom and the legislature's funding priorities.

It is imperative that WCU maintain its enrollment so that access to care is expanded. For this, and the reasons above, we urge you to support this application.

I write in support of West Coast University's (WCU) application to enroll 220 core nursing students each term (five terms per year) of its Baccalaureate of Science in Nursing (BSN) program for each of its Southern California campuses, located in Anaheim, Ontario, and Los Angeles. I understand this item is anticipated to be on the agenda for consideration during the October 2023 Education Licensure Committee meeting and the November 2023 Board of Registered Nursing full meeting.

As the representative for the 73rd Assembly District, located in Orange County, I am very familiar with the relationship between West Coast University and the healthcare facilities in my region. The school has a strong reputation for graduating students who are competent and diverse, and it maintains facilities, faculty, and clinical partners necessary for ensuring its students' success. That is clear when looking at the school's graduation rates, NCLEX passage rates, placements rates, and default rates.

Throughout my time in the Legislature, I have heard regularly about the healthcare workforce challenges that plague the state. The pandemic has exacerbated the problem, thus contributing to nurses retiring and/or experiencing burnout. 
